After a short distance, the vehicle came to a stop. Routine checks listed the vehicle as stolen out of Minneapolis. Four occupants were taken into custody and the vehicle was impounded. Hennepin County Crime Lab processed the vehicle and located possible stolen property. All property was seized. The driver, a 16 year old male, was booked at the Hennepin County Jail for felony motor vehicle theft and felony flee police in a motor vehicle. The passengers, a 15, year old male, a 16 year old male, and a 17 year old male were all released to a parent/guardian and each will be mailed a citation for tampering with a motor vehicle, theft (related to case number 17011480), and curfew violation.</p>
